This letter is in final response to your Freedom of Information Act (FOIA) request dated December 20, 2020. Your request sought:

A copy or printout of the YouTube Creator's Page for the CFPB which shows nonpublic videos on the Bureau's YouTube account. This page is available from the Bureau person responsible for the CFPB YouTube account. The filter setting used on the YouTube creator's page to get these records is UNLISTED and/or PRIVATE.

On December 22nd, you provided further clarification for this request:

A copy or printout of the YouTube Creator's Page for the Bureau of Consumer Financial Protection, which shows nonpublic videos on the agency's YouTube account. This page is available from the agency person responsible for the agency's YouTube account.

A search of our Public Affairs office for documents responsive to your request produced a total of 4 pages. Of those pages, I have determined that 3 pages of the records are granted in full, 1 page is granted in part, and 0 pages are withheld in full pursuant to Title 5 U.S.C. § 552 (b)(6).

FOIA Exemption 6 exempts from disclosure personnel or medical files and similar files the release of which would cause a clearly unwarranted invasion of personal privacy. This requires a balancing of the public's right to disclosure against the individual's right to privacy. The types of documents and/or information that we have withheld consist of information belonging to a third party that are considered personal. The privacy interests of the individuals in the records you have requested outweigh any minimal public interest in disclosure of the information. Any private interest you may have in that information does not factor into the aforementioned balancing test.

You may appeal any of the responses or decisions set forth above. If you choose to file an appeal, you must do so within 90 calendar days from the date of this letter. Your appeal must be in writing, signed by you or your representative, and should contain the rationale for the appeal.
