A copy or printout of the YouTube Creator's Page for the Council of the Inpectors [sic] General on Integrity and Efficiency (CIGIE), which shows nonpublic videos on the CIGIE YouTube account. This page is available from the agency person responsible for the CIGIE YouTube account.

The requested record is provided as a redacted attachment. Pictures and names have been redacted per FOIA exemption (b)(6) to protect privacy.

the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist.

A requester may appeal a determination denying a FOIA request in any respect to the CIGIE Chairperson c/o Office of General Counsel, Council of the Inspectors General on Integrity and Efficiency, 1717 H Street NW, Suite 825, Washington, DC 20006. The appeal must be in writing, and must be submitted either by:

- (1) Regular mail sent to the address listed in this subsection, above; or

Your appeal must be received within 90 days of the date of this letter. The outside of the envelope should be clearly marked "FOIA APPEAL."
